Message from the President

Dear CIVIC Members,

Wow, has it been a year already since our last Annual Report? Well, not quite, which I'll address a few paragraphs down.

But first, let's again celebrate another outstanding year of CIVIC accomplishments!

Here are the highlights with respect to the International Visitor Leadership Program (IVLP), compared to 2013:

- We increased the number of visitors to Eastern Iowa from 96 to 120 (up 25%).
- We increased the number of countries represented from 38 to 51 (up 34%).
- We hosted 25 programs this year, beating the previous record of 23 set last year.

All of this is even more impressive when you realize that we did it in only 10 months, as opposed to the usual 12 months; which brings me back to the topic of my opening paragraph...

CIVIC changed its fiscal year in 2014 to run from October to September, as opposed to the January to December calendar year we had previously. We did this to align our accounting with the fiscal years of the US State Department and our national partner Global Ties. This change will simplify accounting burdens and strengthen the transparency of our reporting to all of our stakeholders who provide funds through grants, membership dues, and in-kind contributions.

That was just one of several actions we took this year to improve our financial stewardship. Other actions we took include the implementation of a financial control policy, and –perhaps most exciting of all– creating an online platform for collecting donations and membership dues. This technological enhancement has already paid dividends, as several new members and donors found us online because of it.

With that out of the way, CIVIC can continue to focus on the important matter of bringing global leaders to Eastern Iowa to engage with CIVIC members and stakeholders! CIVIC's greatest asset continues to be the active, knowledgeable, and internationally savvy residents of Eastern Iowa, which our visitors constantly remind us of in their post-visit reports.

So, 2012 was good, 2013 was great, and 2014 was stellar! I for one can't wait to see what Jo and her staff have in store for 2015!





Message from the Executive Director

Greetings CIVIC members, volunteers, community partners and friends! We've had a great year! It's been eight months since I joined the CIVIC team and, in that time, I've often been awed and overwhelmed by the spirit of volunteerism that our members demonstrate regularly and willingly. It's been an education and an inspiration. In the process, we've accomplished quite a lot, but opportunities for growth and improvement remain.

We've made important strides toward implementing the 2014 Strategic Plan. In April, we held a retreat at which the board established working committees (Membership & Outreach; Fundraising; Operations & Programming; Communications). Each committee is charged with (in collaboration with the staff) achieving the relevant strategic plan objectives. The member-

ship and communications committees have coordinated to grow our membership base by strengthening our communications. The most significant result is our new website where current members can learn about upcoming programs and potential members can learn about CIVIC's important work, join and donate. The CIVIC team has also striven to make the details of program escorting clearer by implementing the Program Escort Quick Guide. We've taken steps toward the development of a corporate outreach initiative to raise funds so that we may expand our operational capacity. The Operations and Programming Committee has drafted a new Financial Oversight and Control Policy, which establishes clear responsibilities and a system of checks and balances to ensure sound financial stewardship and transparency to all of our stakeholders.

One area in which the CIVIC staff and interns have spent significant time is on growing the number of our visitors. To do so we've labored to strengthen our proposals to the State Department by more adequately demonstrating the relevance and depth of our resource pool. And Washington is responding. But this is only half of the programming equation. A successful visit hinges upon our members' engagement with visitors. International Visitor Leadership Program participants value their professional meetings, but their ideas about the diversity of U.S. culture, and the openness and generosity of Iowans is cemented through their engagement with you! You make it possible for us to build global ties locally. In collaboration with membership and communications committees, the CIVIC staff hopes to continue a dialog with our members about the ways in which you'd like to engage with visitors. We want to hear from you about the types of events or programming that you'd like to see.

Raising CIVIC's profile (locally, nationally, and globally) has also been an important objective. The aim is to increase awareness about CIVIC to grow the number of engaged members at the local level in order to meet the national demand to bring visitors to the area. (This fall, we actually turned visits down because we simply didn't have the operational capacity to host the visit.) But we've doubled our social media efforts and continue to look at ways to capitalize on its potential to reach new members. This past year, the local press highlighted several of CIVIC's visits, including coverage of Human Rights activists from the Caribbean and a Bangladeshi Project on Ending Domestic Violence Against Women. Attention to this type of rights-based projects earned CIVIC this year's Bill Reagan Community Award sponsored by the Iowa City Human Rights Commission. The staff, interns and board are grateful to new member Tammy Coverdale Bauer for the nomination!

The Human Rights Commission awards ceremony presented the opportunity to explain CIVIC's work to an engaged community audience. In accepting the award on behalf of you—our members—the board, and the staff, I expressed gratitude for the wealth of resources our community partners provide, which permits us to host a variety of projects centered on social justice issues. In discussing CIVIC's mission, I emphasized that we also hosted many projects seemingly not connected to human rights issues. Nonetheless, these projects help us to advance a more peaceful, sustainable world order. Today, given the magnitude of the global challenges we face: widespread conflict, climate change, and economic uncertainty, we risk being paralyzed by inaction, by not knowing what we can do as individuals or as a community. CIVIC gives us the opportunity to be out there every day, working toward mutual understanding, fostering international cooperation, and developing global solutions. It's what citizen diplomacy is all about!

I'm looking very forward to another busy year, building friendships across national borders with all of you!



CIVIC Membership Update

Membership recruitment was identified as a top priority at the CIVIC board retreat on April 5, 2014. As a non-profit organization promoting citizen diplomacy in Eastern Iowa, CIVIC depends on an engaged and connected volunteer base. CIVIC's Strategic Plan calls for raising its profile and increasing membership to 130. To implement this directive, a new membership standing committee was formed and has been meeting with the Executive Director monthly since May. The committee was not one student intern but is still looking for more CIVIC members, one CIVIC member, and one student intern but is still looking for more CIVIC members to share their ideas and energy and serve on this committee. Are you interested?



Our twin objectives are to expand and engage membership. CIVIC has seen a modest gain over 2013 of ten more members with 96 paid memberships in 2014. To further the membership drive, the committee approved two new CIVIC brochures drafted by student interns. Have you seen them? Available on the website, take a look. One flyer specifically targets students and touts such benefits of membership as cultural competency, networking and global connections. The brochures were handed out at the University of Iowa Cultural Diversity Fair on October 5th. A second general brochure also encourages joining CIVIC to become a citizen diplomat and build global ties locally. Brochures are made available at CIVIC events like Meet and Greets to reach potential new members. We welcome your feedback.

Student interns, in consultation with the membership and communication committees, conducted a general membership survey to gather information on why members join CIVIC and what you find rewarding. Thank you for participating! Interns also updated our membership data base. After CIVIC made the change from calendar year to fiscal/academic year, the Executive Director, intern and membership committee needed to draft new membership forms and letters. Membership dues remain at the same rate of \$10 for student, \$35 for individual and \$55 for household. Additional financial support levels now feature diplomatic designations: Attaché, Chargé d'affaires and Ambassador, to recognize your contribution to citizen diplomacy. The new streamlined membership form enables members to tell CIVIC how you would like to engage with international visitors. Space is provided on the membership form for referrals as we continue to rely on our current members to recommend new members. Please feel free to recommend potential names at any time. In October, our proactive Executive Director asked each board member to identify five potential new members that CIVIC should invite to the special Meet and Greet, "Connecting Eastern Iowa with the Middle East and North Africa." Non-member guests who came to this event received individualized letters thanking them for attending and then invited them to join CIVIC. As a result, six new members joined! One new recruit from Rockwell Collins in Cedar Rapids has helped CIVIC meet another goal of expanding membership beyond Iowa City and Johnson County. The membership campaign to add 40 new members in 2015 is our challenge and goal. Please join us in this drive and thank you for supporting CIVIC. CIVIC Finance Report

2014 Fiscal Year Annual Report

CTVIC has moved its fiscal year to track the federal fiscal year and that of our primary grant agency, Global Ties. As a result, the 2014 FY was an abbreviated one that ran from January 1, 2014 to September 30, 2014. The 2015 FY began on October 1, 2014 and will end on September 30, 2015. The Global Ties grant remains our largest source of funding. We continue to enjoy a mutually beneficial partnership with International Programs at the University of Iowa. UI International Programs provides office space and critical operational support for a nominal fee as well as \$1500.00 in funds that may be used to offset additional university-related expenses. (UI funds are distributed over the academic year.)



Our Global Ties grant is calculated based on the number of visitors and projects we hosted during the previous federal fiscal year. We earn points based on an equation that uses the total number of international visitors, programs hosted, and the type of program (e.g. individual or regional). The points accumulated determines the grant "band." For the 2014 grant year, we achieved the "125-150" point bandwidth (based on 2013 visit numbers). This earned CIVIC a Community Partnership Grant totaling \$35,102.00. We maintained our grant bandwidth this year. To jump to the next band width would require an increase in our operational capacity.

Here is a brief breakdown of our 2014 FY financials (rounded to the nearest dollar).

Summary: The outlook for the 2015 fiscal year is excellent. We are already recruiting and obtaining new international visits. With increased membership and volunteers we may be able to increase our band width to the "150-175" level, which would increase our grant funding for the 2016 fiscal year. Additionally, given the operational stabilization over the past few years, we look to strengthen our emergency fund this fiscal year, improving CIVIC's long-term fiscal security.
